

**Alaska Department of Revenue**  
**Oil & Gas Production Tax Annual Tax Return Form Project**  
**Public Workshop**  
**Thursday, December 9, 2010**

The Department of Revenue is holding a public workshop to discuss its draft Oil and Gas Production Tax Annual Return form for the 2010 filing that will be due on March 31, 2011. For 2010 reporting the department is proposing that the information on "Input" forms 2 – 6 will be required in addition to the "Tax Summary" form located at Tab 7. Forms 2 -6 are: 2. Input General, 3. Input Volume, 4. Input GVPP, 5. Input Lease Exp, and 6. Input Credits. The remaining forms are optional and need not be filed with the annual tax return, however, these supplemental forms may be used by taxpayers as an aid to calculating a company's tax liability.

Draft Cook Inlet Tax Return Sample Company 2010  
Draft Non-North Slope Non-Cook Inlet Tax Return Sample Company 2010

Forms have been provided in both Excel Workbooks.xlsx and also in Excel 97-2003.xls. The department recommends the use of the more recent "xlsx" version of Excel. A consolidated form that combines all three reporting areas will be made available prior to the workshop. Interested parties are encouraged to review the draft forms prior to the workshop.

Comments and suggestions are requested from interested parties and potential users of the Oil & Gas Production Tax Annual Return form no later than January 10, 2011. Early submission of comments is encouraged.
