

**Alaska Department of Revenue**  
**Draft Oil & Gas Production Tax Annual Tax Return Form**  
**Make-up Web Workshop**  
**Tuesday, July 10, 2012**

The Department of Revenue will hold a make-up web workshop to discuss its proposed draft Oil and Gas Production Tax Annual Return form for the 2012 filing that will be due on April 1, 2013. The web workshop is intended as an introductory overview of the draft return and will walk through a draft return for the Sample Company for the 2012 calendar year. The subject matter and draft return will be the same as was discussed during the public workshop on Thursday, June 28. Due to circumstances beyond the control of the department, connectivity to the internet was lost by the department just prior to the June 28 workshop. This loss of connectivity prevented the department from hosting the web portion of the workshop as scheduled. The department apologizes for the inconvenience this may have caused parties interested in participating in the workshop.

Early submission of comments is encouraged. Note that our current license limits the department to 25 participants. Accordingly the department requests that if two or more individuals from your organization will be viewing the workshop that arrangements for a conference room or other similar common area be arranged. Additional workshops may be held as necessary.
